I do want all of you to know that we are fortunate in finding this location as it was the ONLY location that we were able to secure for 2024. We are looking forward to celebrating Champagne, Bubbles and Corgis in Morgantown, PA, April 17-19, 2024. PWCCP FAST CAT AND THIRD ANNUAL CORGI/CLUMBER RUMBLE

The Pembroke Welsh Corgi Club of the Potomac faced its greatest Fast CAT challenges so far starting Friday with unseasonable heat, moving to high winds and rain on Saturday causing a one- hour delay, and ending with sunny, windy, and cold conditions on Sunday. October 6, 7, and 8 tested the endurance of the 285 dogs who made 570 runs at our 2023 Fast CAT events.

The Third Annual Corgi Clumber Rumble was held on Friday, Oct. 6 with 18 Clumbers and 22 Corgis racing for ribbons and trophies along

with corgi and clumber spectators all over the Gamber carnival grounds. A pot-luck picnic followed with an awards ceremony and a gift basket raffle donated by Glenna Felty. Clumber Thunder members Hayley Tamburello and Ken Herringer were the official score keepers for the Corgi and Clumber placements. Ken also entertained us as our Master of Ceremonies and Awards Presenter. In addition to rosettes for the top ten fastest of both breeds, we awarded big, sparkly rosettes to the fastest corgi and clumber. The much-coveted Turtle rosette and "Slow as a Herd of Turtles" trophy was bestowed upon the slowest corgi and clumber for the day. For the first time we recognized the fastest Veteran of each breed. The Corgi Veteran ribbon was donated by Kandy Boll and her 11-year-old Yummy claimed the award running an amazing time of 13.82 seconds. The party ended with our photographer, Mark Baer, gathering us all together for a group photo.

The weekend ended on a somber note when one of our well-loved PWCCP members, Vicki Trexler, passed away suddenly on her way home to southern VA. She had made the long trek to Finksburg because she wanted her dog, Cierce, to title at our event.

Thank you to all the volunteers who worked so hard over three days to make the PWCCP Fast CAT weekend a success. Doug Biernacki, Ted Schwartz, Heidi Kennedy, and Jen Reynolds at the Start Line, Michele Pohl, Kandy Boll, Barb Boltz, and Mary Kay Heberling at Inspection/Check-in, Sherrie Biernacki, Carol Crivelli, Jen Crivelli, Carol Jackson, and Kara Ellison manning the Ribbons table, and Stephon Collins and Jacqueline Barbour controlling the chaos at the Catch Pen. Deb Wimer handled hospitality for the entire weekend with a bottomless pot of coffee, endless snacks and a beautiful set-up of tables ladened with food for the Rumble picnic.

This year for the first time we offered two days of Fit Walks. Fourteen owners and their dogs followed the one-mile route around the carnival grounds to earn an AKC title and receive a purple ribbon for their effort. Thank you to Phoebe Rolen for explaining the route to the walkers and recording the information for submission to the AKC.

Thank you to our intrepid photographer, Mark Baer, who endured everything the weather could throw at him. Lying on the cold, wet ground in the pouring rain in shorts and bare feet as the dogs barreled toward him, some rewarded him with a smooth or, in the case of one Clumber, snuggled by his side at the end of the run.

Finally, a huge thank you to Ching. Without him there is no Fast CAT weekend. He keeps us all in line and runs the safest, smoothest, and most fun events for us and especially for our dogs.



I was asked to write something about remembering my friend Vicki Trexler. Well, I hardly know how to begin, as she was bigger than life, if you truly knew her. Who dances at presidential inaugurals balls, or rides horses across Mongolia and the Pony Express Trail? These are just a tiny part of the life of Vicki Trexler. There wasn't a trip we made or a person we met that didn't have some kind of a connection to Vicki. She filled her 74 years of life. The day I first met Vicki, she showed up with her corgi Chloe for me to evaluate as a potential show dog. She had bought Chloe at a horse show, as she was showing horses on the circuit down in Florida. While Chloe was a very cute black headed tri, I didn't think she would champion easily. Vicki accepted my advice and left for home with the dog she adored. Sadly she lost Chloe at seven years to cancer. I got a call from Vicki wanting to come out and visit my puppies and think about a future show dog. We talked for a long time and this led to her first show dog CH Morningstar Moonlight Mermaid, "Ariel." Arial produced CH Moonlight Shadow At Morningstar, "Luna," which became her first homebred

champion. Many others were to follow. She was hooked; she became involved in her local kennel club, Tidewater Kennel Club of Virginia, where she held many officer positions, and served as Chair and Co Chair for our shows. She joined and served on the BOD of the Pembroke Welsh Corgi Club Of Potomac and later joined the Pembroke Welsh Corgi Club Of America. She enjoyed her dog show family, and even when I was unable to make the trips, with puppies at home, Vicki would hit the road on her own.

Vicki was very social and giving of her time. She served on Norfolk's Saint Judes BOD, James River Hunt, Norfolk Master Gardeners, Chesapeake DAR, Norfolk Sports Club, and I am sure there were more. She was proud to have been a business owner of a successful wine and deli shop in Norfolk.

Vicki loved to shop and we made a game of collecting all things corgi, our motto being "No Corgi left behind!" Vicki loved spending long afternoon lunches chatting and laughing with friends. She loved her family and was blessed with many grandchildren she adored. Often Vicki would sit ringside and needle point beautiful ornaments for special friends and family.

There were so many family events we shared from weddings, births, illnesses, and deaths over the years that we became family, not by blood, but by love. She was truly my sister. She was my Ride or Die! "Ride or Die:" the highest level of loyalty you'll ever find in a person."

Vicki Berry Dickerson Trexler, 74, hailing from Norfolk, passed away on Saturday, October 7th, while in the embrace of a Richmond Hospital. Vicki entered this world on May 28th, 1949, in Norfolk, as the beloved daughter of the late David and Georgia Berry. She graduated from Maury High School and pursued her education at Old Dominion University. Vicki was the proud owner of the West Side Wine Shop in Norfolk and a longtime member of Christ & St. Luke's Episcopal Church. Vicki was predeceased by her late husband, Dr. John W. Dickerson, and her stepson, James Dickerson.

Left behind to cherish her memory are her loving husband, Peter L. Trexler, and her daughters, Vicki Wilson (Andy) and Kellie Dickerson, all residing in Norfolk. She is also survived by her stepchildren, Janet Dickerson Richard of Charlotte, Peter Trexler Jr. (Stacey) of Midlothian, Michelle Sheldon of Prince George, and Coleman Trexler (Anne) of Henrico. Vicki is fondly remembered by her siblings, Georgia Mason (John), David Berry (Liz) of Norfolk, and Jacqueline Walton (Dennis) of New Hampshire. Additionally, she leaves behind numerous beloved grandchildren, great-grandchildren, nieces, and nephews.

Vicki was an active community advocate, always eager to contribute her time and energy to various organizations. Her extensive list of affiliations includes The Norfolk Sports Club, James River Hunt, Norfolk Master Gardeners, the Great Bridge

Chapter of the DAR, Tidewater Kennel Club, and Pembroke Welsh Corgi Club of the Potomac, among many others. She was a passionate photographer and enjoyed pursuits such as needlepoint, horseback riding, and traveling. Her travels took her to many countries, and she cherished the memories of horseback riding on the Pony Express Trail and across Mongolia, considering them the trips of a lifetime.

In her later years, Vicki's heart belonged to breeding and showing Pembroke Welsh Corgis. She trained them to be champions while pampering them like her own children.

The family extends their heartfelt gratitude to the compassionate care team in the Neuro-Science ICU at Johnston-Willis Hospital for their unwavering support during Vicki's most challenging hours. While expressions of sympathy are welcome in any form, the family kindly requests that donations in Vicki's memory be made to EVMS Foundation: John Dickerson Memorial Lectureship or to St. Jude's Children's Research Hospital. Vicki's legacy of love and community involvement will continue to inspire all who had the privilege of knowing her.

A funeral service will be held at Christ & St. Luke's Episcopal Church on Tuesday, October 17, 2023 at 1:30 PM. Interment to follow at Forest Lawn Cemetery

Vicki joined the PWCCP in 2013. From the day she joined, to the sad day that she passed, she has always been a bright and happy member of the PWCCP. We remember her smile, her laugh and the helpfulness to many who were involved in putting on club events, or sitting at ringside, enjoying the day. She had a sincere and tenacious loyalty to her dogs and to the endeavor of breeding pure bred Pembroke Welsh Corgis. She worked well with others and people loved her.

AKC Fetch titles were created as another activity in which owners could have fun with their dogs in the AKC Family Dog program. Earning AKC Fetch titles provides opportunities for both physical and mental exercise. While some dogs are natural retrievers, AKC Fetch, especially at the advanced levels, will involve teaching new skills such as retrieving.


AKC Fetch is a pass-fail noncompetitive test. The four levels of titles (Novice, Intermediate, Advanced and Retriever) assess the ability of the dog to retrieve. In the Advanced and Retriever levels, the dog must respond correctly to signals. There is also a memory component in Advanced and Retriever because a retrieving bumper or ball is dropped (or thrown) behind a blind where it cannot be seen.



For each of the four titles, the dog must pass the test twice under two different approved AKC Fetch judges. Fetch judges can be any AKC judge or CGC evaluator. Since the test must be taken twice with two different judges, and there are four different title levels, Fetch would make a good club-sponsored all day event.

In order to receive a FREE unframed certificate designed in 2014 by Art Smith, applicants will adhere to the following: The owner of record for the free award certificate will be the PWCCP member name listed on the AKC registration papers; applicant must have been a PWCCP member in good standing when the award was earned; and, must have attended at least 1 General Membership meeting during the calendar year in which the award was earned. In the case of multiple PWCCP member co-ownerships, each co-owner may receive a free <u>unframed</u> certificate provided they meet the aforementioned criteria. The owner must be a PWCCP member in good standing at the time the title was achieved and when the award request was submitted. If applicable, in the Top Award category where there are multiple PWCCP member co-ownerships, each co-owner may receive a FREE framed certificate provided they meet the aforementioned criteria. Submission will not be accepted without the proper forms and documentation. All entries must be received by February 1, 2024. NO EXCEPTIONS.

Advertising in The Tide is limited to PWCCP members and PWCCA-affiliate club members. Advertising rates for non-PWCCP members (unless invited to advertise because of a PWCCP specialty or match win) and commercial businesses are double the PWCCP member rates and are subject to approval by the editor. Advertising on the front cover or on page two is available by invitation from the editor.

Please review the following guidelines so that all the information that you wish to include is provided to us. This will prevent us from having to request additional information and will help to avoid confusion by having everything submitted at the same time.

Any or all of the following items may be submitted:

- Registered and call name of the dog.
- Sire and dam. It is generally a good idea to include the sire and dam for conformation Corgis. Sire and dam may be included for performance dogs. Rescue Corgis in performance under the AKC PALS program would not have a breed history, so would not have this included.
- What was achieved? What accomplishment(s) are you advertising?
- Where was it achieved (location and show)?
- Under which judge?
- On what date?
- Breeder (may be acknowledged formally or with such phrases as heartfelt thanks, etc.)
- Handler (including owner/handler and in the case of a handler not the owner may include thank yous).
- Owner (in the case of a particularly crowded ad, where the owner/handler is pictured, this can be noted in the picture).
- Photos: You must supply the name of the photographer or studio, even if you took the pictures yourself. It
 is the policy of The Tide to give attribution on all photos. Attribution is a legal requirement for professional
 photos. If there are special circumstances where the photographer is not known, please discuss with the
 Advertising Editor, or with the Editor.
- People in the photos: Judge and professional handler may be identified out of courtesy and as helpful information. Owner/handler is optional if ad is submitted by the owner/handler.
- Kennel logos are a good idea and may be included.
- Phone numbers, addresses, and email of breeders can be included by the breeder or with permission of the
 breeder if they are the advertiser, a member or if they co-own the dog with the advertiser. Publication of
 non-club members' names, addresses, and phone numbers may be listed in the Tide for those who co-own
 dogs with the advertiser.
- Finally, include any special text or explanations. (Please note that space is limited, and a long text will result in much smaller pictures, etc.)
