Directions to the PWCCP B-OB Rally Specialty Match, Picnic and Annual Meeting:

From Wash., DC: DC Beltway (I-495) to Georgia Ave (Rt. 97); turn left onto Jennings Chapel Road. Turn right at the fork in the road to Daisy Rd.; proceed through the only stop sign to #2850 on the left.

From Baltimore: I-70 to Rt. 97 (about halfway between Baltimore and Frederick). Go south onto Rt. 97. Turn right onto Rt. 144, then left onto Daisy Rd. Proceed about two miles to #2850 on the right.

From Frederick: I-70 to Rt. 94. Go south on Rt. 94 to Rt. 144 East. Turn right onto Daisy Road. Proceed about two miles to #2850 on the right.
