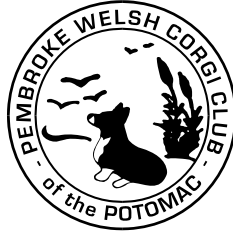

**Closing date:** Friday, September 10, 2010 or when limit is reached (entries will remain open until limit is reached)

**– Clinic and Test Hours –**

Clinic starts at 8:30 on Saturday and 8:00 on Monday  
Tests start at 9:00 on Sunday and following the clinic on Monday

**– Important Entry Limits –**

**Clinic:** 25 dogs Saturday, 10 dogs Monday

**Tests:** HCT & JHD total 50 dogs Sunday (25 per judge), HCT & JHD total 15 dogs Monday

Limit of 40 sheep runs per day, balance will be run on ducks

Spectators welcome all three days. Plenty of free parking.

**DIRECTIONS**

**From the North:** I-95 to Baltimore Beltway (I-695) West to Route 795 North to Route 140 (Westminster) to Center Street, Westminster. Turn right onto Gist Road, right onto Smith Avenue to show grounds.

**From the South:** I-95 to Capital Beltway (I-495) to I-270 North to Route 27 North. Turn right onto Kate Wagner Road. Turn left onto Gist Road. Turn left onto Smith Avenue to show grounds.

**From the East:** Route 50 to Capital Beltway (I-495) to I-95 North to Baltimore Beltway (I-695) to Route 795 North to Route 140 (Westminster) to Center Street. Turn right onto Gist Road, right onto Smith Avenue to show grounds.

**From the West:** Route 70 East to Route 27 North. Turn right on Kate Wagner Road. Turn left onto Gist Road. Turn left onto Smith Avenue to show grounds.

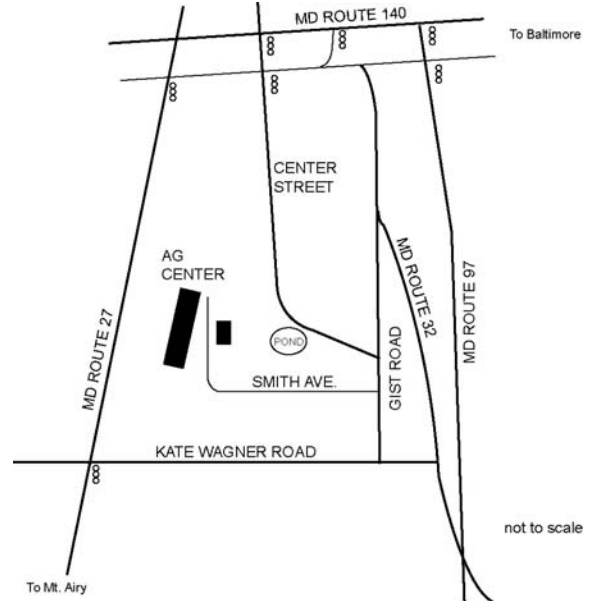
**Please drive safely. Please drive SLOWLY when you reach Carroll County Agriculture Center.**

## IMPORTANT INFORMATION

If sending entries overnight or via delivery service, please sign waiver to allow driver to leave package *without signature*.

**RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY. A \$20.00 collection fee will be collected on returned checks before entries are accepted.** Entries NOT on entry forms are unacceptable. Entries will not be accepted without fees. No refund for duplicate entries or any other cause beyond the control of the PWCCP after the closing date. Telephone, telegraph, fax, or e-mail entries cannot be accepted. All entries must be signed.

**ERRORS ON ENTRY FORMS:** Owners are responsible for errors in making out entry forms and no entry fees will be refunded in event of such errors or cancellation of entries after the published closing date. Please type or print the information clearly and carefully on entry forms to eliminate errors. Changes, additions, or corrections to Entry Forms must be received in writing prior to the closing.

**DECLINED ENTRIES:** The PWCCP may decline any entries and may remove any dog on account of disease, viciousness, or other cause and no one shall have any claim against the aforementioned club or any official thereof.

**ENTRY FEES SHALL NOT BE REFUNDED** in the event a dog is absent, not allowed to compete in the entered class, disqualified, excused by a Veterinarian or Judge, or barred from competition by any action of the Test Committee. If because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or complete the Test, no refund of entries will be made.

**ALTERNATE LIST:** When entry limits are reached, additional entries received prior to closing will be added to an alternates list. The alternates list will be used to fill vacancies that occur in the drawn running order.

**BITCHES IN SEASON** will not be permitted in clinic or test classes.

**No dog may be entered twice in the same test class. A dog may be entered in 1, 2, or 3 tests under either/both judges. Entry fee is \$45.00 for EACH test run.**

**PLEASE PICK UP AFTER YOUR DOG!!!** All dogs present must be held on leash or otherwise restricted except while being judged. Dogs will not be allowed to disturb resting stock or interfere with another dogs' performance in the arena.

**FOOD:** Maryland law has changed recently, and requires that food offered for sale at events (such as the Great Herding Weekend) must be prepared by a licensed caterer. The PWCCP has contracted with *Convenience Catering* to provide food for sale during the herding weekend. Complimentary coffee and donuts will be provided by the PWCCP each morning.
